

ORDINANCE NO. 2009-2010-F

An ordinance amending the 2009-2010 Fiscal Year Budget of the City of Victoria by transferring \$150,660 from the Motel Tax Fund fund balance to (1) Motel Tax Fund Victoria Symphony line item, (2) Motel Tax Fund Victoria Bach Festival line item, (3) Motel Tax Fund Cultural Council line item, (4) Motel Tax Fund Texas Settlement Region line item, (5) Motel Tax Fund Children's Discovery Museum line item, (6) Motel Tax Fund Theatre Victoria line item, (7) Motel Tax Fund Victoria Regional Museum line item, (8) Motel Tax Fund Quilt Guild of Victoria line item, and (9) Motel Tax Fund Victoria Ballet Theatre line item, to provide funding for outside agencies, repealing all conflicting ordinances, providing for severability; and declaring an effective date.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF VICTORIA, TEXAS:

1.

The Fiscal Year 2009-2010 Budget of the City of Victoria is amended by transferring **\$13,500** from the Motel Tax Fund fund balance (1015-300100) to the Motel Tax Fund Victoria Symphony line item (1015-15MOT-670070), to provide funding to the Victoria Symphony Society; and

The Fiscal Year 2009-2010 Budget of the City of Victoria is amended by transferring **\$10,000** from the Motel Tax Fund fund balance (1015-300100) to the Motel Tax Fund Victoria Bach Festival line item (1015-15MOT-670071), to provide funding to the Victoria Bach Festival; and

The Fiscal Year 2009-2010 Budget of the City of Victoria is amended by transferring **\$26,000** from the Motel Tax Fund fund balance (1015-300100) to the Motel Tax Fund Cultural Council line item (1015-15MOT-670090), to provide funding to the Cultural Council of Victoria; and

The Fiscal Year 2009-2010 Budget of the City of Victoria is amended by transferring **\$4,000** from the Motel Tax Fund fund balance (1015-300100) to the Motel Tax Fund Texas Settlement Region line item (1015-15MOT-670110), to provide funding to Texas Settlement Trails, Inc.; and

The Fiscal Year 2009-2010 Budget of the City of Victoria is amended by transferring **\$5,000** from the Motel Tax Fund fund balance (1015-300100) to the Motel Tax Fund Children's Discovery Museum line item (1015-15MOT-670140), to provide funding to the Children's Discovery Museum; and

The Fiscal Year 2009-2010 Budget of the City of Victoria is amended by transferring **\$55,260** from the Motel Tax Fund fund balance (1015-300100) to the Motel Tax Fund Theatre Victoria line item (1015-15MOT-670160), to provide funding to Theatre Victoria; and

The Fiscal Year 2009-2010 Budget of the City of Victoria is amended by transferring **\$27,000** from the Motel Tax Fund fund balance (1015-300100) to the Motel Tax Fund Victoria Regional Museum line item (1015-15MOT-670240), to provide funding to the Victoria Regional Museum Association; and

The Fiscal Year 2009-2010 Budget of the City of Victoria is amended by transferring **\$2,400** from the Motel Tax Fund fund balance (1015-300100) to the Motel Tax Fund Quilt Guild of Victoria line item (1015-15MOT-670180), to provide funding to the Quilt Guild of Greater Victoria; and

The Fiscal Year 2009-2010 Budget of the City of Victoria is amended by transferring **\$7,500** from the Motel Tax Fund fund balance (1015-300100) to the Motel Tax Fund Victoria Ballet Theatre line item (1015-15MOT-670190), to provide funding to the Victoria Ballet Theatre.

2.

If any provision of this ordinance, or the application thereof to any person or circumstance, shall be held invalid or unconstitutional by a court of competent jurisdiction, such invalidity shall not affect the other provisions, or application thereof, of this ordinance which can be given effect without the invalid provision or application, and to this end the provisions of this ordinance are declared to be severable.

3.

All ordinances or parts of ordinances in conflict with this ordinance are repealed to the extent of such conflict.

4.

In accordance with Article V, Section 5 of the Charter of the City of Victoria, the City Council finds a grave public necessity

exists to amend the original budget to authorize the aforementioned expenditures to meet unusual and unforeseen conditions involving funding for outside agencies, which could not by reasonable diligence, thought and attention have been included in the original budget.

5.

This ordinance shall take effect upon final approval and adoption by the City Council of the City of Victoria.
