This resolution will expend \$ 32,974.00, and I have verified with the Finance Dep't the availability of these funds in Account #3037-37DOWN-970030 in the Construction Fund(s).

Caption:

A resolution authorizing the City Manager to execute an Agreement for Contribution in Aid of Construction with Bobby Leon (Contributor) for the extension of the Main Street and De Leon Plaza Improvements project, currently under construction on Main Street and Juan Linn Street, at 116 Juan Linn (Chesnick Furniture building), specifically the sidewalk along 2 sides of the building at the intersection of Juan Linn and Bridge Streets, in the amount of \$32,974.00.

Description:

Under this agreement, the City will reconstruct the sidewalks adjacent to the Chesnick Furniture Company, located at the intersection of W. Juan Linn and S. Bridge Streets, in return for payment from Mr. Leon in the amount of \$32,974.00.

The reconstruction of these sidewalks will be added to the existing Main Street & Deleon Plaza Improvement Project and will be constructed using brick pavers in a manner consistent with the work that has previously been completed for this project.

The Department of Public Works recommends approval of this resolution.
